SUMMARY

Educator

Early in my professional career, my collegiate preparation was to prepare me to be an excellent teacher of accounting, a dean and a college president. I was fortunate to achieve the first two goals through the building of a department of accounting at a regional university at which the then "Big Eight" recruited our students. My mentors were members of the Oklahoma Board of Accountancy who impressed upon me the responsibility of providing the highest quality education including business ethics to the students who entrusted their academic preparation to our department of accounting. Also, I served as a faculty member of Oklahoma State University, school of accounting while earning my doctorate and after retiring from KPMG LLP as visiting professor of accounting at the University of Oklahoma Steed School of Accounting.

Public Accounting Expereince

Dr. Johnson has more than 40 years of experience specializing in the practice of financial institutions, higher education, government, not-for-profit and retail accounting. He was the partner-in-charge of the KPMG Southwest Higher Education, and Oklahoma Not-for-Profit and Government practices. In addition, Dr. Johnson was a partner with the firm of Lisle, Compton, Cole and Almen in Oklahoma City, which merged into the firm of BKD, and Horne & Company of Ada, Oklahoma. Also, he was of counsel to Oklahoma City office of Eide Bailly, LLP. In summary, Dr. Johnson earned partnership responsibilities with two well-known local firms in Oklahoma and is a retired partner of KPMG.

Dr. Johnson is self employed as a certified public accountant and a management consultant and is affiliated with BKD LLP of Oklahoma.

Oklahoma Society of CPAs

Dr. Johnson has held all of the leadership positions of the OSCPA and is a member of its Hall of Fame. Soon after becoming a member of the OSCPA, Dr. Johnson through his leadership as chairman of the OSCPA CPE committee created the infrastucture to involve the Oklahoma Academic Community in the activities of the OSCPA. In addition, the curriculum offerings available to members were increased to provide a diversity of offerings to all segments of the membership (industry, financial services and management consulting).

Dr. Johnson received the Special Recognition Award from the AICPA board of directors recognizing his career of Public Advocacy for the public and profession. He served as Chairman of the Uniform Accounting Act Committee of the AICPA (five years) and was a member for a prior three term, was a Member of the original AICPA 150 Hour Committee, the original committee to promote the concept of Substantial Equivalency and the original Leadership Committee of 100. He made many presentations to various professional groups supporting the 150 Hour educational requirement to enter the profession and the concept of Substantial Equivalency and why each is in the best interest of the public. Working with the staff of the AICPA, developed the workbook "Implementation of the 150 Hour Requirement". Also, he served as a member of the Awards Committee for three years. He has instructed training seminars for various professional associations at both the national and state levels for multiple years.

Oklahoma Board of Accountancy

Dr. Johnson has held all of the leadership positions of the OAB and is the past chairman (three years). Subsequent to taking his position as a member of the OAB, Dr. Johnson lead the OAB transformation to the world of technology through the development of an online registration system for firms and individuals, licensee search system and implementation of a modernized web site for use by the public to determine the status of firms and individuals registered with the OAB. He also lead the development of the uniform enforcement system. As noted on the following pages, Dr. Johnson has served five governors and leaders of the Oklahoma state legislature on reform and re-engineering task forces and committees.

National Association of State Boards of Accountancy

Participation in NASBA has included serving as Chair and Vice Chair and as a director since 2006. As Vice Chair and Chair, Dr. Johnson lead the effort to review the governance structure of NASBA toward more transparancy and accountability by the executive staff, executive committee and board of directors. Also, in those roles he has increased NASBA's participation in various higher education projects: Pathways Commission, accreditation and association with the American Accounting Association. As chair of various committees he lead the efforts to strengthen regulation of the profession (Uniform Accountancy Act Committee), strengthen boards of accountancy (Board Relevance and State Legislative Support Committees), and provide oversight for NASBA's financial reporting and internal controls including the adoption of an audit charter (Audit Committee).

As a member of the board of NASBA, Dr. Johnson provided leadership to the implementation effort of Substantial Equivalency in state licensing requirements by meeting with various state boards and attorneys general to discuss the importance of Substantial Equivalency and the changes necessary in statutes. As chairman of the Audit Committee, initiated the development of an audit committee charter, led the committee in the adoption of the best practices for audit committees of not for profit organizations and a review of the qualifications of the external auditing firm. As chairman of the State Board Relevance and Effectiveness Committee in cooperation with its members, led the effort to develop a Rationale Document regarding why boards of accountancy should be self directed and semi-independent (SD-SI). Also, led the development of a template for the modification of a state statute and the development of a budgetary template to assist state boards with a convenient tool to create "what if" budgets to support a SD-SI board. With two state board executive directors and members of the Legislative Support Committee developed and populated a web site to provide documents, articles, testimony, etc. to provide Boards with immediate resouces to respond to various

inquiries. Also, Dr. Johnson has served as the chair of the Uniform Accountancy Act Committee (UAA)which creats the model accountancy act for the 55 boards of accountancy. Serving the public interest, Dr. Johnson lead the completion of the "Firm Name Exposure Draft" and its adoption by the respective boards of directors of NASBA and AICPA resulting in the Sixth Edition of the UAA. In addition, he lead the adoption of a new rule to the UAA, providing that the SAS 70 service bifarcated as an Attestation Service continue as a covered service subject to board of accountancy jurisdiction.

It has been my privilege to work with public accounting firms engaged by clients of the broker dealer with which I was associated for a period of nine years. It is paramount that the firms understand the public relied on the financial information the firms audited and or reviewed to make investment decisions.
