Overview of the Course

This course is not about teaching people how to be "good." Most wrongdoing in business settings is actually committed by good, mostly honest people who make bad choices — sometimes due to pressure, but often because they are unaware of the ethical dilemmas they are facing or are utilizing self-serving rationalizations to justify their decisions. This course aims to help students learn to increase their ethical awareness and develop a consistent ethical decisionmaking process that will minimize the chances of making unethical decisions. In addition,



students will learn how to become ethical managers, lead others to make ethical decisions, and develop ethical cultures within their organizations.

Course Goals and Objectives

The objective of this course is to increase the student's ability to manage the ethical aspects of business. Each student will develop skills necessary to recognize, analyze and address ethical issues, to provide ethical leadership within and for the organization, and to conduct business responsibly.

Course Format

Although this is an on-line course, the topic requires a lot of discussion. As you will learn throughout this course, analyzing ethical dilemmas can be quite complicated, and it is important to understand other people's ethical perspectives. In addition to watching lectures and reading assignments, you are required to engage in on-line discussions. You will also be assigned homework assignments that will allow you to better understand the way you reason about ethics. The overall purpose of the discussions and homework assignments is to provide you with insight into how you are likely to respond to ethical dilemmas in the workplace and whether your approach is the "optimal" approach. The goal of this course is to give you guidance in terms of how to better respond to and manage ethical dilemmas in the workplace.

Discussion Board Participation (150 points total, 15% of your final grade)

Please see the course schedule (at the end of the syllabus) for discussion posting deadlines.

Each week there will be one or more discussion board postings. Students are required to participate in discussions for course credit. Please note that you will be graded on the quality of your posting (e.g., how thought-provoking and insightful your comments are), in addition to your follow up responses to classmates' comments/questions/insights.

Important

Some of the course discussions will require preliminary preparation. For example, you might be asked to read a case study, a supplemental article, or watch videos related to the chapter we are covering. In these instances, I will try to alert students that discussion participation will be lengthier than normal so that you can prepare accordingly.

Please note that I may provide comments to your discussion posts on the discussion board, or through a weekly video rather than through the actual discussion board. Often, my comments are not to agree or disagree with your post, but to provide a different perspective or play devil's advocate to try to get you to think deeper on the topic. If I use a weekly video, I will provide summary points regarding the discussions, and I will also provide my own insights/comments regarding the particular questions.

You are also expected to read the posts of your classmates, and to occasionally provide responses. Your responses are expected indicate where you agree or disagree, offer different perspectives, and to stimulate discussion. Remember that while we might not all agree on how to resolve an ethical dilemma, we need to be courteous to each other and show respect for other



points of view. Please be aware that I may include some of the discussion topics and posts as a part of the exams in the course.

Below is my grading rubric for the discussion posts. Because posts are meant to further discussion among the class, posts made after the due date will not receive credit.

Homework Assignments (100 points/assignment, 200 points total, 20% of your final grade) *Please see the course schedule (at the end of the syllabus) for homework deadlines.*

You will be required to submit two homework assignments throughout the semester. Each homework assignment is worth 50 points each, for a total of 100 points. You can submit a late homework assignment up to one week (7 days) after the homework is due, but at a penalty of 50% of your grade. In other words, the maximum amount of points you can receive once the deadline has passed is 25 points for that particular assignment. Late homework assignments will not be accepted at all after one week (7 days) of the deadline. In some cases, you might not be penalized for late homework assignments if something occurs in accordance with university specified excused absences (e.g., you're sick and have a doctor's note, you attended a funeral and have documentation, etc.).



Term Paper (150 points total, 15% of your final grade)

You will have a 5-page (minimum) term paper this semester. The term paper is worth 150 points, or 15% of your grade. The paper will be based upon a film or documentary from a list I will provide. You are to write an analysis of the ethical issues presented. Further instructions will be located under "content" in Brightspace under "Term Paper." Your grade will be based upon how well you understand and apply the concepts per the instructions provided, as well as the persuasiveness, organization, and structure of your paper. Please carefully review the instructions and rubric provided. Failure to do so will hurt your grade. Also, if you are unable to turn the paper in on time, please notify me before the due date. Papers turned in after the due date will be penalized unless extenuating circumstances exist.

Exams (250 points/exam, 500 points total, 50% of your final grade)

Please see the course schedule (at the end of the syllabus) for exam dates. All exams will need to be taken at a testing center (to be arranged with the Online Learning office) and will be administered on-line with immediate feedback.

Students are expected to take two non-cumulative exams throughout the semester. The exams will include a combination of multiple choice and true/false questions. The exams will cover the specified chapters, including my lectures, assigned supplemental readings and videos, and corresponding discussions. Please note that if I request you to watch a short video as part of a particular chapter discussion, then that video will be fair game for the exam as well. In other words, you should review *all* material when preparing for the exams. The content for each exam is noted below.

Exam I: Chapters 1-5, and materials assigned weeks 1-4. Exam II: Chapters 6-11, and materials assigned weeks 5-8

Exam Procedures

Exams in this course will require a proctor. You much take each exam at an approved testing center. After you have completed the appropriate form(s) and sent into the Online Learning Office make sure to call your testing center to schedule an appointment.

Makeup Exams

You may be eligible for a makeup exam if you have an excused absence. An absence is considered excused if 1) you are out of town because of military deployment, 2) you are sick or hospitalized, or 3) you are attending a funeral. In all cases, I <u>must</u> be informed of your absence prior to the exam, <u>and</u> I must receive documentation within one week of the absence. If you cannot reach me directly, please send me an email.

If you have been approved for a makeup exam, you'll need to forward my email approval to the Online Learning Office. Online Learning will work with you to arrange a make-up exam at your testing center.

Letter grades will be assigned according to the standard scale.
