**EPHD Alumni have been recognized in September for their recent research.**

[Jonathan Butler, PhD](#), (Cohort I) who is an Assistant Professor of Entrepreneurship at [Marshall University](#) was honored at the [2015 Babson College Entrepreneurship Research Conference](#). Founded in 1981, BCERC is considered by many to be the premier entrepreneurship research conference in the world. Jonathan's paper, "*The Dark Triad, Employee Creativity, and Performance in New Ventures*," was selected as one of the top papers at the conference and will be published in the conference proceedings.

[David Altounian, PhD](#), (Cohort I) who is an Assistant Professor of Entrepreneurship & Interim MBA Program Department Chair at [St. Edward's University](#) in Austin, TX. was honored at the [2015 Engaged Management Scholarship Conference](#) in Baltimore, MD. The EMS Conference is the preeminent venue for sharing the research and knowledge produced in executive doctoral programs. David's paper, "*Casual or Committed? Using Social Behavior Theories for Understanding the Contributors to User Commitment in User Generated Content Sites*" was chosen as best paper at the conference.

[Steven Wilson](#) (Cohort II) also participated in the EMS Doctoral Consortium in Baltimore presenting his paper, "*Antecedents to Successful Business Succession Planning in Small Professional Services Firms*."

[Michael Bosman, MD](#) (Cohort II) had two papers, "*Managers' Attitudes toward Adoption of Evidence-Based Management: An International Comparison*" and "*Marketing a Paradigm Shift: How to Sell the Evidence-Based Management Approach*," and a poster accepted by the EMS Conference and also participated in the Alumni Consortium. [Nathan Higdon](#) (Cohort III) also had a poster accepted by the EMS Conference. Several other OSU students, alumni, and faculty attended and represented OSU on various EMS committees.
