#### Briefly describe your role and responsibilities as an intern.

The responsibilities as a summer intern in the consulate are to work closely with the Ecuadorian community in the U.S., Americans, and other diplomatic missions in the U.S. As a consulate we have the power to issue Ecuadorian documentation, such as passports, powers of attorney, visas, safe passages, etc. For this, I had to learn the international treaties that Ecuador has with other countries, and a little bit of law in order to understand what a consulate does.

#### What did your internship teach you about this career field?

It taught me that every economic decision made in the diplomatic world affects our daily lives. For example, we were promoting the extension of a duty-free access for all the exports that come to the U.S. from Ecuador, called ATPDEA. That means millions of jobs affected directly and indirectly for Ecuador and the U.S., if Congress does not pass this bill. This kind of economic decision made by policy makers could change the job market and the prices for goods. After this experience I will see my classes as more interesting than before because they are really relevant to the world.

### What impacted your selection of this major?

Economics is a social science, and depending upon where you work, you could change the reality of a society with economic decisions. I chose this major for that reason. Because everything is related with economics I personally believe that the level of happiness is measured by the level of needs fulfilled. In this world, and especially in this country, those needs can be fulfilled with money.

### What classes best prepared you for the job?

I would say any English or Speech courses would be very helpful; courses that make you write essays or do presentations/speeches. It can be overwhelming to talk in front of people you don't know or maybe in front of your boss, so the more practice you have, the better you will do in those situations. ### Briefly describe your role and responsibilities as a new hire.
