Business students must have 33 hrs of Business Core (18 hrs in residence at OSU) **plus** requirements listed for specific minor area. (6 of 9 hrs in minor area must be in residence)

- A. **Accounting** – ACCT 3103 and 6 hrs of upper-division ACCT (C or better in EACH accounting course).
- B. **Economics** – 9 hrs of upper-division ECON; **must have a 2.0 GPA in the 15 hrs of ECON required.**
- C. **Entrepreneurship** – See separate declaration form.
- D. **Finance** – 9 hrs of upper-division finance excluding FIN 4063 (FIN 4223 and 4333 recommended).
- E. **Information Assurance** – MSIS 3123 and 6 hrs from MSIS 4243, MSIS 4253, MSIS 4273.
- F. **International Business** – 9 hrs from MKTG 3993, MKTG 4553, LSB 4633, FIN 4213, MGMT 4613, MGMT 4693, ECON 3613, ACCT 4763.
- G. **Management** – MGMT 3123, MGMT 3313, and MGMT 4073.
- H. **Human Resource Management** – MGMT 3313, and 6 hrs from MGMT 4123, MGMT 4133, MGMT 4153, MGMT 4213, MGMT 4713, MGMT 4813.
- I. **Management Information Systems** – 9 hrs which must include: MSIS 2203, MSIS 3103 or MSIS 3333, and 3 hrs upper-division MSIS **excluding 3223.**
- J. **Management Science & Computer Systems** – MSIS 3233, 3103, 4263.
- K. **Marketing** – 9 hrs of upper-division marketing in addition to MKTG 3213.
- L. **Sports Management** – MGMT 3943 and 6 hrs from MGMT 4743, MGMT 4843, MGMT 4943.
- M. **Sustainability** – 9 hrs from MGMT 3023, 4073, 4083, 4093.

Minimum of 2.0 average in all courses required for the minor.

“P/NP” grades are not acceptable in a course required for the minor.

Substitutions in minors are generally not permitted.

PROCEDURE

1. Student should file the completed *Minor Declaration Form* in the Business Student Success Center, 103 Business.
2. BSSC personnel will verify the minor.
3. Staff will forward to registrar to be recorded on student’s transcript.
